**ORDER**

It has come to the notice of the undersigned that progress of construction of Individual Household Toilets (IHHL) is going on very slow in Lohit District. Poor performance of some Gram Panchayat has been viewed seriously in the meeting of District Level Sanitation Committee chaired by Deputy Commissioner. In light of the importance of this mission & target of achieving goal of ODF District by October 2017, following directions are issued for strict compliance by all concerned.

1. Any village or Gram Panchayat which does not construct toilets (as per the beneficiaries list) by 30<sup>th</sup> Sept'2017 will not be eligible for any government schemes or funds.
2. Any individual household which is already included in beneficiary list but fail to construct toilet by 30<sup>th</sup> Sept'2017 will not eligible for any government schemes/subsidy. Further his/her name will be removed from beneficiary list & will never be included in future.
3. Preference for any Govt Schemes or fund will be given to OPF Gram Panchayat/village only. All HODs while selecting schemes/Individual beneficiaries shall check with PHED & UD Department about status of sanitation & ODF.
4. As per the Government of India's direction, piped water supply will be implemented in ODF village/Gram Panchayat only.
5. Any Individual who constructs a new house without constructing toilet will not be eligible for applying water supply connection and electricity connection.
6. Those villages/GPs which do not constructs toilet up to 15<sup>th</sup> Oct'2017, their water supply and electricity connection will be disconnected.
7. Open Defecation will also increase the numbers of Mosquitoes resulting in the increase of Malaria cases.
